



OFFICIAL RACE VENDOR AGREEMENT

CAROLINA CUP FOOD VENDORS POLICIES

1. All Concession Vending units brought in must be self-contained and no larger than 20' x 20'.
 2. All concessions spaces and Paddock Tents will be marked with your vendor name by the Carolina Cup Racing Association. Please stay within your allocated space.
 3. No glass beverage containers may be sold on the grounds of Springdale Race Course. This is for the safety of all our participants.
 4. A limited number of Vendor Tags and Parking Credentials will be provided for each vendor. A list of employees entering the property must be provided upon acceptance.
 5. The South Carolina Department of Health and Environmental Control (DHEC) could be inspecting onsite on race day. It is each food vendor's responsibility to be in compliance with all the appropriate regulations, including licensing fees.
 6. Please plan to bring all of your supplies with you at the time of your arrival on-site. No re-admissions allowed on race day.
 7. Set up is allowed until 5:00 pm the Friday preceding Saturday's race day, or Saturday race day gate #1 opens for vendors at 7:30 am for set-up.
 8. Gates open to the public at 9:00 am on race day. Post time for the first race is approximately 1:00 pm. Vendors can expect to break down at approximately 5:00 pm.
